This Privacy Policy describes the types of information we may collect from you or that you may provide when you visit www.propprofessor.com (our "Site") and our practices for collecting, using, maintaining, protecting, and disclosing that information. This Privacy Policy applies to information we collect:

- On this Site, whether accessed via a desktop computer or mobile device.
- In email, text, and other electronic messages between you and this Site.

This Privacy Policy does not apply to any information collected by any third party, including through any application or content (including advertising) that may link to or be accessible from or through the Site.

Please read this Privacy Policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use the Site. By accessing or using this Site, you agree to this Privacy Policy. #### Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Site, including information:

- By which you may be personally identified, such as name, postal address, email address, telephone number, and social media username or handle ("Personal Information").

- That is about you but individually does not identify you.

#### We collect this information:

- Automatically as you navigate the Site. Information collected automatically may include usage details, IP addresses, and information collected through various tracking technologies.

We use various service providers for payment processing, website hosting, and for account login management. However, when you provide financial information such as a full credit card number or debit card number to sign up for a subscription on our Site, it is provided to our secure e-commerce provider, Stripe, and we do not receive and cannot access that information. ### **Information You Provide to Us**

The information we collect on or through our Site may include:

- Information that you provide by filling in forms on our Site. This includes information provided at the time of subscribing to our service or registering to use the Site through our service providers or by registering to be an affiliate of our Site, such as name, physical address, email address, and telephone number. Individuals who apply to be affiliates of the Site will also be asked to provide social media usernames or handles.
- Records and copies of your correspondence (including email addresses), if you contact
  us.
- Records of which services and information you choose to display on your customized view of the Site (i.e., which leagues and sportsbooks you choose to display upon login).
- Details of transactions you carry out through our Site and of the fulfillment of your
  orders, such as purchasing a subscription. You will be required to provide payment
  information and other Personal Information to our e-commerce provider before placing
  an order through our Site, but we do not have access to your payment information
  directly.

You also may provide information to be published or displayed (hereinafter, "posted") on public areas of the Site or transmitted to other users of the Site or third parties such as social media sites (collectively, "User Contributions"). Your User Contributions are posted on and transmitted to others are your own risk. We cannot control the actions of other users of the Site with whom you may choose to share your User Contributions. ### **Information We Collect through Automatic Data Collection Technologies**

We may disclose Personal Information that we collect or you provide as described in this Privacy Policy:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of MeetAtEight's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Information held by MeetAtEight about our Site users is among the assets transferred.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- With your consent.

We may also disclose your Personal Information:

- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.

- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of MeetAtEight, our customers, or others.

Our servers and offices are located in the United States, so your information may be transferred to, stored, or processed in the United States. By submitting your Personal Information to the Site, you accept and agree that your Personal Information may be transferred to and stored in the United States. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy.

#### **Do Not Track**

Our Site currently does not respond to Do Not Track requests.
